Carol and the center signed up for the TLC program and quickly got to work. The center was about to send Carol to NIFLA's Institute in Limited Obstetric Ultrasound when the COVID-19 shutdowns began. Years of planning led to this moment – but almost instantly, the pandemic thwarted all of these efforts.

The center was open and providing lay counseling and resources, but they were getting more and more desperate phone calls. The women reaching out were already stressed due to their unplanned pregnancies, but the added uncertainty of a pandemic made it seem unbearable. Carol and the team were convinced that they needed to move forward.

With your unwavering generosity, NIFLA was able to continue working. NIFLA staff stayed in close contact with Carol while the NIFLA legal and medical team went to work providing timely information about the complicated COVID-19 shutdowns. 
